This disclosure is a good faith estimate and serves as an addendum to the property marketing and rental criteria.

## Move-In Charges

Security Deposit	Starts at One Month's Rent Minus \$300	May increase based upon applicant's credit, criminal, employment, and rental history.
Lease Administration Fee	\$300	Non-refundable
Pro-Rated Monthly Recurring Charges	Based on Move-in Date	Pro-ration of all applicable monthly recurring charges.
Pet Deposit	\$400	Deposit is charged for each pet.
Pet DNA Registration Fee	\$50	Registration fee is per pet. Property Specific.

## Violation Charges

Late Fees	10% of Monthly Rent	5-day grace period.

Eviction Fee	\$500	Charged when an eviction has been initiated.
Service of Notice Fee	\$50	Charged for each notice posted for lease violation.
NSF Fee	\$20	Charged for each returned payment.
Utility Turnover Fee	\$50	Charged when utilities are turned over into management's name due to an unpaid balance.

Application Fee	\$50	Per applicant.
Property Inspection Fee	\$50-\$100	Charged when an inspection is required due to a violation. Property Specific.
Month to Month Fee	15% of Monthly Rent	For leases on a month-to-month term after completion of initial lease term.
Re-Key Fee	\$150	Charged when tenant changes locks without authorization.
Online Payment Transaction Fees	\$2.49-\$9.99, or 3.49%	Based on payment type and amount of payment.
Lease Transfer Fee	\$350	Charged when lease is transferred from one tenant to another.
Return Possession Fee	\$400	Charged when possession of unit is returned prior to the completion of lease term.
Lease Buyout Fee	2 Months of Rent	Charged when lease is broken via a buyout.
Abandonment Fee	\$450	Charged when notice is not provided, and unit is deemed abandoned by inspection.
Extra Key	\$2-\$3	Charged when additional keys are requested outside of what is offered with the TBP.
Extra Key Fobs	\$35	Charged when additional fobs are requested.
